The Fixed Rate Bonds described herein (the "Bonds") were sold to First Tennessee Bank N.A., INTL FCStone Financial Inc. - BD Rates Division, Incapital LLC and Stifel, Nicolaus & Company Incorporated (the "Dealers"), as principals, for resale to investors at varying prices according to prevailing market prices at the time of resale as determined by the Dealers. Redemption: The Bonds are not subject to redemption prior to the Maturity Date.

Reopenings: The outstanding principal amount of this issue may be increased from time to time.
