The Fixed Rate Bonds described herein (the "Bonds") were sold to BNY Mellon Capital Markets, LLC and Wells Fargo Securities, LLC (the "Dealers"), as principals, for resale to investors at varying prices according to prevailing market prices at the time of resale as determined by the Dealers. Terms set forth below unless otherwise defined have the meaning ascribed to them in the Offering Circular.

Denomination: \$1,000 and integral multiples of \$1,000 in excess thereof

Interest Rate: 2.625%

Day Count Basis: Interest shall be computed on the basis of a 360-day year consisting of twelve 30-day months.

Redemption: The Bonds are not subject to redemption prior to the Maturity Date.

Reopenings: The outstanding principal amount of this issue may be increased from time to time.
