Partnership and Wells Fargo Securities, LLC (the "Dealers"), as principals, for resale to investors at varying prices according to prevailing market prices at the time of resale as determined by the Dealers. The Bonds have the same terms (other than the Issue Date, Settlement Date and the Issue Price) as, and form a single issue with, the 2.875% Bonds Due December 21, 2023 issued in the original principal amount of \$150,000,000 on December 21, 2018 at an Issue Price of 100.000%, and pursuant to the Term Sheet dated December 14, 2018 (the "Original Bonds"). The total principal amount of the Original Bonds and the Bonds is \$170,000,000.
