The Floating Rate Bonds described herein (the "Bonds") were sold to TD Securities (USA) LLC (the "Dealer"), as principal, for resale to investors at varying prices according to prevailing market prices at the time of resale as determined by the Dealer. The Bonds have the same terms as, and form a single issue with, the Bonds Due August 4, 2020 issued in the original principal amount of \$100,000,000 on January 4, 2019 at an Issue Price of 100.000%, and pursuant to the Term Sheet dated December 28, 2018 (the "Original Bonds"). The total principal amount of the Original Bonds and the Bonds is \$200,000,000.
