Terms set forth below unless otherwise defined have the meaning ascribed to them in the Offering Circular.

The Bonds have the same terms (other than the Settlement Date and the Issue Price) as, and form a single issue with, the 2.710% Bonds Due April 15, 2027 issued in the original principal amount of \$30,000,000 on April 15, 2019 at an Issue Price of 100.000%, and pursuant to the Term Sheet dated April 8, 2019 (the "Original Bonds"). The total principal amount of the Original Bonds and the Bonds is \$40,000,000.
