The Optional Principal Redemption Bonds described herein (the "Bonds") were sold to Wells Fargo Securities, LLC (the "Dealer"), as principal, for resale to investors at varying prices according to prevailing market prices at the time of resale as determined by the Dealer. Terms set forth below unless otherwise defined have the meaning ascribed to them in the Offering Circular. **The Bonds are continuously callable on any day on or after August 15, 2024 as described below in "Redemption".**

The Bonds have the same terms as, and form a single issue with, the 2.250% Bonds Due August 15, 2029 issued in the original principal amount of \$150,000,000 on August 15, 2019 at an Issue Price of 100.000%, and pursuant to the Term Sheet dated August 8, 2019 (the "Original Bonds") and reopened in the principal amount of \$10,000,000 on August 15, 2019 at an Issue Price of 100.000% and pursuant to the Term Sheet dated August 9, 2019 (the "First Reopening Bonds"). The total principal amount of the Original Bonds, the First Reopening Bonds and the Bonds is \$170,000,000.
