The Bonds have the same terms (other than the Issue Date, Settlement Date and the Issue Price) as, and form a single issue with, the 1.500% Bonds Due September 6, 2022 issued in the original principal amount of \$25,000,000 on September 6, 2019 at an Issue Price of 100.000%, and pursuant to the Term Sheet dated August 29, 2019 (the "Original Bonds"). The total principal amount of the Original Bonds and the Bonds is \$105,000,000.
