FARM CREDIT SYSTEM BANKS PRICE 2-YEAR DESIGNATED BOND TOTALING \$1 BILLION

JERSEY CITY, NJ – The Federal Farm Credit Banks Funding Corporation today announced the pricing of the 2-Year Designated Bonds settling on May 16, 2022. The Designated Bonds will be issued through the Federal Farm Credit Banks Consolidated Systemwide Bond Program.

The issue was lead managed by Citigroup Global Markets Inc. and Daiwa Capital Markets America Inc. Co-managed by Academy Securities, Inc. and Loop Capital Markets LLC.
