The Bonds are continuously callable on any day on or after April 10, 2025 as described below in "Redemption".

Redemption: The Bonds may be redeemed, at the Banks' option, by the Funding Corporation, as agent for

the Banks, in whole or in part, on any day on or after April 10, 2025, together with interest accrued but unpaid, from and including the most recent date on which interest has been paid, to but excluding the date on which such Bonds are to be redeemed (each such date on which the Bonds are to be redeemed, a "Redemption Date") at a redemption price, after payment of interest due on such Redemption Date, of 100% of the principal amount thereof to be redeemed. In the event of a partial redemption, a pro rata portion of the outstanding principal amount of each Bond will be redeemed. Notice of redemption shall not be less than 5 Business

Days prior to the Redemption Date.

Reopenings: The outstanding principal amount of this issue may be increased from time to time.
